Jinhui Shipping and Transportation Limited (the "Company") is pleased to announce that the 2020 Annual General Meeting of the Company (the "Meeting") was held at 26/F, Yardley Commercial Building, 1-6 Connaught Road West, Sheung Wan, Hong Kong SAR, the People's Republic of China on the 19th day of May, 2020 at 9:30 a.m. and the following resolutions were duly passed:

1. FINANCIAL STATEMENTS

It was resolved that the audited Financial Statements, the Directors' Report and the Independent Auditor's Report for the year ended 31 December 2019 thereon submitted to the Meeting be and are hereby received and adopted.

2. **RE-ELECTION OF DIRECTOR**

It was resolved that in accordance with the bye-laws of the Company, Mr. Ng Ki Hung Frankie retired from office and, being eligible, offered himself for re-election. The Meeting voted on the candidate nominated, and Mr. Ng Ki Hung Frankie was re-elected as Director of the Company for the term contemplated by bye-law 36 of the Company's bye-laws.

4. **REMUNERATION**

The Directors' emoluments for the year 2019 as disclosed in note 12 to the audited Financial Statements for the year ended 31 December 2019 was reported in the Meeting. It was further resolved that the Board of Directors is authorized to fix the Directors' remuneration for the ensuing year.

It was further resolved that the guideline for the remuneration of executive personnel submitted to the Meeting be and is hereby received and adopted.

5. **AUDITOR**

It was resolved that Grant Thornton Hong Kong Limited, the retiring auditor of the Company, be and is hereby re-appointed as auditor of the Company to hold office until the conclusion of next annual general meeting and it was further resolved that the Board of Directors is authorized to fix the auditor's remuneration for the ensuing year.

6. SPECIAL RESOLUTIONS

It was resolved that the following resolutions were duly passed as SPECIAL RESOLUTIONS:

- (a) that any resolution passed prior to the date of this Resolution granting a general mandate to the directors of the Company to exercise all the powers of the Company to issue, allot and dispose of shares of the Company in accordance with the terms of such previous resolution be and is hereby revoked; and
- (b) that a general mandate be and is hereby generally and unconditionally granted to the directors of the Company which mandate shall be valid until the earlier of (i) the date of next annual general meeting; or (ii) otherwise revoked or determined by members at a general meeting of the Company to exercise all the powers of the Company to issue, allot and dispose of shares of the Company not exceeding the aggregate of thirty per cent. (30%) of the issued share capital of the Company on the date of this Resolution and such allotment, issue and disposal of shares of the Company shall not be subject to any preferential rights of members of the Company as provided by bye-law 4.3 of the bye-laws of the Company.
